A MESSAGE FROM SHERIFF SCOTT A. STEWARD

To the citizens of Park County:

During 2012, the Park County Sheriff's Office continued our community service policing philosophies which emphasizes safety, service and security for all residents. Our department employs a staff of highly trained, dedicated law enforcement personnel and it is indeed a privilege for us to serve the needs of the citizens of Park County by continuing to provide high-quality, professional policing services.

Our Patrol Division saw a 5.76% increase in the number of calls for service in 2012 which included over1,600 criminal and non-criminal investigations, over 850 civil processes served, over 650 criminal warrants closed through arrest, over 2,500 motor vehicles inspected for titling purposes and over 1,100 security checks of residences and businesses in need of added surveillance.

Our Detention Division booked a total of 1,145 prisoners into the holding facility for an average inmate population of 63 prisoners per day; a 26% increase over 2011. New bookings increased 10% and despite increases in total bookings, new bookings and average inmate population, our officers' use of force incidents totaled a mere 13. These incidents are created whenever a detention deputy has to utilize restraint on a non-compliant inmate. We continually strive to keep these incidents to a minimum by providing the best possible training to our deputies in methods to mitigate situations prior to resorting to physical force.

Our Communications Division provides point-of-contact emergency dispatch and 9-1-1 answering services for the Park County Sheriff including Search & Rescue as well as the Cody Police Department, West Park Hospital ambulance, and Cody/Meeteetse/Clark/Powell fire agencies. In 2012, they handled a total of 44,354 calls for service which works out to an average of 5,544 handled by each of our eight dispatch personnel.

So, as you can see, 2012 was an extremely productive year for agency personnel. Our personnel pledge to continue providing the service expected by our citizens as we proceed into the New Year and beyond.



Patrol Division

After a modest decline in 2011, the Park County Sheriff's Office Patrol Division saw a 5.76% increase in the number of calls for service in 2012. This increase can be attributed to our community policing efforts, aimed at quick and early detection of potential problem issues, as well as our aggressive traffic enforcement program aimed at a reduction in dangerous driving behaviors.

Being proactive in preventing crimes and traffic accidents within our communities, have increased the overall safety and security of our residents. Our email tip line also continues to provide us with vital information regarding potential criminal activity as well as ongoing investigations.



In 2012, each patrol deputy handled an average of 1,099 incidents.

MOTOR VEHICLE CRASHES

In 2012, the Park County Sheriff's Office investigated 142 Motor Vehicle Crashes in Park County. There were 4 fatal crashes, 26 crashes with minor injuries and the remaining 103 had no reported injuries. By working an increased amount of traffic enforcement we are hoping to reduce the number of motor vehicle crashes that we respond to in 2013.

The investigation of your motor vehicle crash is a thorough and detailed investigation as we not only complete a report for our own department records, but we complete a traffic accident report for the State of Wyoming that has diagrams attached. The investigation process involves a complete scene evaluation and records evidence such as skid marks, crash debris, traffic control devices, surrounding properties and aspects of the roadway. This information is then available to your insurance company for settlement of any claims. A review of the crash report can give information regarding the occupants, drivers, vehicles, citations, witnesses, and layout of the scene.

While we strive to reduce the amount of crashes, some preventable crashes still occur through driver inattention and such simple things as driving too fast for conditions are still major contributors to the number of crashes we respond to. The Park County Sheriff's Office is working hard to get the message out to the public that if you crash and the road conditions are icy or hazardous, you will most likely receive a citation if the investigation determines you to be at fault.

In 2011, the Park County Sheriff's Office celebrated its 100th anniversary as an agency by changing the color scheme on 3 new vehicles that we were purchasing for our fleet. The Sheriff decided since we were a century old that he would have the cars ordered in black and we would make them look like a classic patrol car from the early days of the Sheriff's Office.

After researching the materials and costs, we determined that there was no cost difference in the color and the order was placed. Unfortunately, due to delays on the part of the car builder, we didn't receive the cars until the beginning of 2012. We continued on and the 3 cars that we ordered were marked with the graphics of the Sheriff's Office and on the rear fenders a slogan was added that said "100 years of service".




Communications Division

In 2012, the Park County Sheriff's Office Communications Division saw a decrease in the total number of calls handled by 2.5 %. This is a reflection of a decrease in activity from a few of the agencies for which we dispatch. As the figures below demonstrate, four agencies had a fairly significant decrease in activity from 2011. As for the agencies that had an increase in activity percentage wise, their volume was so low as to not have a significant effect overall. Each of our 8 Communications Officers processed an average of 5,544 calls for service in 2012.

HOW 9-1-1 TECHNOLOGY AFFECTS CALLERS


When someone dials 9-1-1 in Park County, the call is routed to one of two answering points in the county. This will either be the Park County Sheriff's Office Communications center

located in Cody or the Powell Police Department communications center in Powell. The routing of the calls is done based on what we call geocoding of the location where the call occurs. To put it simply, by building a master streets and address guide (MSAG) we can plot a landline caller exactly where they are calling from on the computerized map. If it's a cell phone 9-1-1 call, the cellular provider uses either handset or network based technology to route the call to the correct communications center. Park County is fortunate that we have a good working relationship with our other communications center and have shared resources such as our mapping software and dispatch software that allow us to visually see the calls in real time at each communications center as they unfold. We do this by having a shared Computer Aided Dispatch (CAD) software program that allows us to prevent unnecessary duplication of data entry. By being able to see what is going on across the county we can be proactive in sending resources to assist each jurisdiction. However, there are times where we run into issues with the technology. One of the problems that we encounter is with the technology used to locate a wireless caller. In the dispatch world, there are three levels of 9-1-1. There is Phase 0, Phase I, and Phase II. We can describe it as basic, intermediate and advanced level of technology used to assist the communications operator to locate you. The Park County Sheriff's Office and Powell PD are fully Phase II compliant providing the best level of technology possible at this time.

One of the things we have noticed nationally is that there are a large number of individuals who are relying solely on cell phones as a primary phone for communications. While cell phone technology is improving greatly every year, it's not going to provide an exact location for the caller every time like a land line would do. We can obtain GPS coordinates from the cell phone provider that will plot on a map, but due to limitations of some cell phone providers, the data can be horribly inaccurate. Another issue is when we receive a Phase I call that shows the cell tower your phone is talking to, but not where you are. It does us no good to dispatch emergency responders to the tower location on the mountain when the caller could be in a 30 mile radius of the tower. We have to request updated information from your cell phone/provider in an attempt to locate the caller with a better degree of accuracy by sending an electronic rebid command to the cell phone which only works some of the time. With this in mind, we are beginning a public education campaign that we hope will improve emergency response for cellular calls.

As a result, it is essential that you stay on the line and clearly give your location to the 9-1-1 operator. A wireless phone is actually a radio with a transmitter and a receiver that uses radio frequencies or channels instead of a direct wire connection to connect callers. The Federal Communications Commission requires communications centers to be Phase II compliant and requires carriers to provide far more precise location information – within 50-300 meters or your actual call location. The cell phone you carry must also be compliant with the technology requirements as specified. All of Park County is Phase II complaint, and continues to strive to improve the technology and data every day in an effort to provide the best services possible to the residents and visitors of Park County.

The following graph illustrates the 9-1-1 calls that Park County has received in 2012. We would like to point out that currently, 77.8% of all 9-1-1 calls are being made from wireless devices and this reflects the national trend as individuals move away from land line phones. There were 7,180 emergency calls made to the Park County Sheriff's Office alone in 2012. We have broken them down by what we call "class of service" to illustrate the types we handle. Notice that the largest amounts of the calls were Phase I which as we stated earlier means all we receive is the location of the cell tower you are connected to requiring us to query the phone and ask it to try to improve its location data. As technology improves, we expect this number to decrease significantly. Our hope is to have all cellular 9-1-1 calls be Phase II once the technology improves enough.




Detention Division

In 2012, the Park County Sheriff's Office Detention Division booked a total of 1,145 prisoners into the holding facility. This number represents a 1% increase in total bookings from 2011. The average inmate population increased from 50 in 2011 to 63 in 2012, a 26% increase.

USE OF FORCE INCIDENTS BY YEAR

The Park County Detention Center also tracks the use of force incidents against inmates within our care and protection. These incidents are created whenever a detention deputy has to utilize force against a non-compliant inmate. This can be in the form of compliance holds such as a wrist-lock up to and including the use of non-lethal weapons such as a Taser or pepper spray. We continually strive to keep these incidents to a minimum by providing the best possible training to our deputies in methods to mitigate situations prior to resorting to physical force.

Assaults by inmates against officers and each other increased in 2012. As with use of force incidents, we continually strive to minimize inmate assaults through training. All inmates who assault officers or other inmates are prosecuted under Wyoming State Statute.
